The Committee then held elections for its 2017 Executive Committee and appointed the following:

Secretary: Nirmala Devi Windgaetter

(Cologne)

Treasurer: Linda Yeoh (Lausanne)

We also thanked the outgoing Executive Committee members Colin (President) and Lydia (Treasurer) for their contribution to GB during 2015/2016, and also to SC member Chong Pin who stepped down for personal reasons, but will continue as an IT Support contributor.

The new SC has agreed to the following priorities for Global Bersih in 2017:

- Overseas Voting Proposal to lobby the Election Commission to implement a robust overseas voting sytem ASAP, and definitely before the GE14 date is announced
- Upcoming GE14 encourage as many as possible overseas Malaysians to register to vote
- Improve the image of GB and strengthen its brand name
- Fundraising explore different types of fundraising possibilities and focus on those as dictated by our capacity

Global Bersih Gathering in Malaysia

On January 2, 2017, Global Bersih (represented by Colin, Bala, Ivy, Kean and Kevin) held a new year's lunch meeting in Kuala Lumpur with Bersih 2.0 (represented by Maria Chin, Jay Jay Denis and Mandeep Singh) and Global Bersih patron and former Bersih 2.0 Chair Ambiga Sreenevasan, to exchange ideas and discuss the future of the Bersih movement and Global Bersih.



While recognizing the challenges facing civil society in Malaysia, Ambiga encouraged the team not to lose hope and to continue the struggle bravely. Main outcome of the meeting was an agreement that GB should focus in 2017 on galvanizing overseas Malaysians to register and participate in GE14. Bersih Chairperson Maria Chin expressed her

appreciation of the solidarity and support shown by the GB cities for Bersih's demands and for the active participation in the Bersih 5 rally.

Overseas Voting Proposal - Introduction

This project is to focus on reforming the overseas voting system to enable all Malaysians living overseas to vote through a fair and efficient system. Before coming up with the proposal, GB collected information worldwide on the real possibilities to vote from overseas. The conclusion was that there was no consistent existing system on overseas registration or voting.

The Malaysian foreign missions overseas have been inconsistent on the possibility for Malaysians to register at the embassies.

Global Bersih's Lydia Chai (who leads GB Auckland) together with the support of many other GB city coordinators, arrived at a proposal to reform the existing system to enable all Malaysians residing overseas to register and vote overseas through a fair and transparent system.


The salient points of the proposal were:

- The term 'overseas postal voting' should be renamed 'overseas advance voting' to correctly reflect the fact that voting would be done in person at foreign missions.
- Overseas advance voting should be implemented on an ongoing basis.
- Additional polling locations that are known as 'field polling centres' should be set up to facilitate overseas voting in areas where Malaysian embassies, consulates or high commissions are non-existent.
- Voter secrecy should be upheld through randomized issuing of ballots and avoiding records of voters' names alongside ballot serial numbers.

More transparency and security are needed by allowing party agents ('overseas agents') who are elected by political party candidates or independent candidates, to wield the same authority and powers as their counterparts would at polling stations in Malaysia. These overseas agents should be allowed to monitor the receipt and opening of ballot sacks/boxes, to control the sealing of ballot bags/boxes and observe the counting of votes at the overseas polling locations.

Global Bersih has submitted the proposal to the EC in Malaysia and some city coordinators have submitted to their respective Malaysian foreign missions overseas. We are also planning to work together with other local and international NGOs, media, and all interested parties to bring this proposal forth. Global Bersih Germany - Meeting with Amnesty International in Germany

The local chapter of GB in Germany had a meeting with the Amnesty International (AI) South Pacific Desk in Frankfurt to discuss the possibility of working together. Global Bersih secretary, Nirmala Devi Windgaetter met up with Andreas Fulda and his AI team in Frankfurt. Global Bersih updated the AI team on the current situation in Malaysia, and the role of GB in the global Malaysian diaspora.

Both parties agreed to keep each other informed about upcoming activities and the possibility of working together in the future.

The quiet effort by YB Senator Datuk Paul Low Seng Kuan who serves as a minister in the Prime Minister's Department in charge of Governance, Integrity and Human Rights to bring greater accountability and transparency to the system is also noteworthy...

Bersih 2.0 Press Statement on Election Commission's Negative Image

On January 13, 2017, Bersih 2.0 issued a <u>press</u> <u>statement</u> on the allegations that the EC's negative image is due to public perception. According to Bersih 2.0, the negative image of EC is indeed a reality due to the five reasons listed below:

- Unconstitutional redelineation exercise
- Flawed and bloated electoral roll
- Inefficient and obsolete voter registration system

- Failure to check electoral corruption
- Failure to advocate "caretaker government code"

Global Bersih Geneva - Upcoming Workshops

Recognising the lack of experience in the complexities of international fundraising and appropriate communication methods and skills, GB Geneva is organizing two workshops for GB supporters.

Fundraising Workshop

Global Bersih is planning a fundraising workship to:

- Understand the objectives and processes involved in funding proposal writing
- Understand the definition and distinction of common jargons used in funding proposal
- Learn good practices on writing a funding proposal

The fundraising workshop will take place in Nyon, Geneva on February 26, 2017, and should take no longer than 3.5 hours.

There will also be a communications workshop planned for March/April 2017.
